THE **LIBRARY** OFFERS A HIGHLY DESIRABLE LOCATION ON THE UPPER FLOOR OF THE MAIN LODGE BUILDING. THIS WARM AND HOSPITABLE SPACE FEATURES A FIREPLACE, ELEGANT CHANDELIERS AND A TERRACE OVERLOOKING THE LAWN ADJACENT TO THE 18TH GREEN OF PEBBLE BEACH GOLF LINKS.

LIBRARY AMENITIES include exclusive use of the Library in The Lodge at Pebble Beach. This private room includes the following furnishings and amenities:
