STEVENSON ROOM

THE **STEVENSON ROOM** IS AN EXPANSIVE GROUND FLOOR SPACE DECORATED IN HUES OF GOLD AND CREAM WITH ITS OWN WET BAR AND PRIVATE RESTROOM. IT IS LOCATED IN THE MAIN LODGE BUILDING AND OPENS ONTO THE LAWN ADJACENT TO THE 18TH GREEN OF PEBBLE BEACH GOLF LINKS.

STEVENSON ROOM AMENITIES include exclusive use of the Stevenson Room in The Lodge at Pebble Beach. This private room includes the following furnishings and amenities:

- Private entrance
- Space to entertain up to 70 guests with a basic décor package
- Air conditioning, lighting and electrical service
- Television broadcast coverage of the U.S. Open Championship
- Private telephone for local usage and credit card calls
- Computerized scoring terminal
- Security for the Stevenson Room during all hours of operation
