Please complete and return this form to take advantage of your opportunity to purchase option tickets to the U.S. Women's Open. Any option tickets ordered will allow access to the championship and into your Point Tent. Option tickets can be purchased on a 5-day or daily basis. Note: The combination of 5-day packages and daily tickets ordered cannot exceed the total allotment of option tickets on any given day.
